**Directions to Wooster K of C Hall**  
**132 S. Buckeye Street Wooster, Ohio 44691**

From the Cleveland area headed south on I-71

- Exit at State Route 83 (exit 204), Turn left heading south (Continue approx. 16 miles)
- Take Exit to US Route 30 West toward Mansfield/Ashland (Proceed approx. 0.2 miles)
- Exit at ramp to Madison Avenue. Turn right onto S. Bever Street (proceed under RR trestle)
- Turn left at South Street (second traffic light) South Buckeye Street is first road on right.
